Kids Power Wheel Derby

This is a fun event for ages 3-9. Balloons will be fastened to the corners of each power wheels car. The objective is to pop all the balloons on opponents' vehicles. The vehicle with the last balloons in place will be the winner.

Prizes for 1st, 2nd and 3rd place.

- All children MUST be accompanied by a parent or guardian.
- Parents must sign waiver before the child can participate.
- Must bring your own power wheel vehicle.
- All drivers must wear approved safety helmets and safety glasses. Bicycle or hockey helmets are acceptable.
- No sandals allowed to be worn during the event.
- NO passengers permitted in vehicles.

POWER WHEELS BUILD

- All vehicles must have 4 wheels; no motorcycles or bikes/trikes will be allowed to participate.
- Stock wheels only, no added screws or chains. Tape may be added around tires to prevent them from breaking.
- Trunk, doors and hoods should be secured with tape, zip-ties or rope to prevent them from opening or falling off during the event.
- No lowering or heightening the vehicles. Must remain factory height.
